PREVENTIVE MEDICINE AS A STRATEGY OF MODERN HEALTH CARE SYSTEM IN THE FIGHT AGAINST THE URINARY SYSTEM PATHOLOGY IN CHILDREN

Health is one of the main conditions that determine the full development of the child. Children's health directly affects future socio-demographic and socio-cultural indicators of the country's population development [1]. The incidence rate and prevalence of diseases are the most important criteria, which characterize children's health [2].

In children population of Ukraine in the structure of morbidity and prevalence of various diseases over the past 5 years, the urinary system pathology took the 7th-8th place and accounted for 2.0-5.0 % [3, 4]. According to the data of the World Health Organization, diseases of the urinary system organs in the structure of morbidity and prevalence of various diseases of children population in economically developed countries occupied the 7th place and amounted to 2.5-3.0 % [5].



The leading strategy of modern health care system in the fight against the urinary system pathology of children should be preventive medicine, which is represented by a set of measures aimed at the prevention of diseases, rather than on their treatment. The basis of preventive medicine is the determination of risk factors, which are understood as potentially dangerous to health factors of behavioral, biological, genetic, social character, environmental factors, increasing the probability of diseases development, their progression and unfavorable outcomes. The effect of risk factors on a person is purely individual and the probability of diseases development depends on the adaptive capacity of the organism [5].

In different regions the contribution of risk factors for the development of the urinary system pathology of children may have its own peculiarities. We have singled out such risk factors for the development of the urinary system organs pathology in children of the Kharkiv Region as a reduced body weight and length of the baby at birth, the female sex of the baby, smoking of its parents, presence of abortions in the mother's case history, complications during pregnancy (placental insufficiency and preeclampsia) and delivery (placental abruption and abnormal labour activity), presence of genital and extragenital pathology in the mother (urinary system diseases).

Thus, preventive medicine should become one of the strategies of modern health care system in the fight against the urinary system pathology of children. The basis of preventive medicine is the determination of risk factors on the basis of which it is possible to make a prediction not only the development of the urinary system pathology in children, but also its character – congenital or acquired.
